Structure, Governance and Management

Governing Document

The Charity is administered in accordance with its Constitution, adopted on 4th November 2009. Charitable status was granted on 10th November 2009.

Recruitment and appointment of Trustees

Trustees are nominated from among the subscribing members of The Friends of the Caird Hall Organ and elected at General Meetings.

At the Annual General Meeting of the Charity on 15th May 2018 Roger Clegg was elected as Vice Chair and Trustee.

Organisational structure

Under the Constitution the Charity is administered by its Committee which comprises the elected Trustees and any co-opted member(s) along with the Halls & Music Development Manager of Leisure & Culture Dundee and the City Organist as ex-officio members. Walter Blair, as a member of the Education Subcommittee, Richard Finch, as Membership Secretary, Andrew Macintosh, as Webmaster, Dr Jim McKellican, as Archivist and Fundraising Officer, and Sheriff Kevin Veal as adviser on constitutional matters are members of Committee by invitation. The Committee meets at intervals throughout the year. Three subcommittees, concerned respectively with Education, Fundraising and review of the Constitution, and whose members include Trustees, meet from time to time and report to the Committee.

Objects

The Charity's objects are:

- (i) the advancement of education of the public in the field of organ music and
- (ii) the advancement of the arts, heritage and culture through the preservation of the Caird Hall Organ and the promotion thereof to the public and in furtherance thereof but not otherwise the Society shall undertake the following activities:-
 - (a) fostering contact among all those interested in the Caird Hall Organ
 - (b) promoting the use of the Caird Hall Organ in recitals, concerts and other musical and educational activities by a wide variety of groups
 - (c) increasing financial security for the future of the Caird Hall Organ
 - (d) supporting specific projects

Achievements and Performance

The Friends have continued to support and promote the magnificent concert organ in the Caird Hall – "the finest concert organ in Scotland". The Trustees met on seven occasions during the year.

At the Annual General Meeting on 15th May 2018 Roger Clegg was elected as Vice-chair and Trustee.

The Friends provided financial and practical support for the Annual Conference of the Scottish Federation of Organists, held in Dundee on 4th-5th May 2018, at which the public celebrity recital was given on the Caird Hall Organ by Martin Baker, Master of the Music at Westminster Cathedral, London. The Friends also supported Leisure & Culture Dundee's 2018 summer organ recital series. A *Come and Sing with Paul Mealor* event on 29th September 2018 attracted singers from across a wide area to perform Vivaldi's *Gloria*, Parry's coronation anthem *I was Glad* and Mealor's own *Let all the World in every corner sing*. On 9th November 2018 a Silent Movie Night featured the public showing of Buster Keaton's classic 1928 film *Steamboat Bill Jr* and Laurel & Hardy in *Big Business*, with Richard Hills providing improvised accompaniment on the Organ. A successful six-hour Organathon on 23rd February 2019 raised a significant sum and new members were recruited.

An educational session on 7th November 2018 was attended by pupils from St Paul's Academy, Dundee, who were able to enjoy the experience of hearing, learning about and, in some cases, playing the organ. Discussions continue with representatives of secondary school staff from Dundee and Angus on how this initiative may be taken forward in future.

The Friends have continued to support the maintenance of the organ by the funding of additional tuning sessions during the year.

The charity's website has undergone major revision during the year to make it more informative and improve its appeal to users. Video recordings of the organ are now available via YouTube.

At the end of the accounting period the Charity had 209 subscribing members.

During the year, banking arrangements have been reviewed and revised to increase security and guard against fraud. A Data Protection Policy in line with current legislation has been implemented.

The Friends of the Caird Hall Organ gratefully acknowledge grant assistance from the Alexander Moncur Trust to support educational work, and unrestricted grants from the Cookie Mathieson Charitable Trust, Leng Charitable Trust, RJ Larg Family Trust, William S Phillips Fund, St Katharine's Fund, Leach Family Charitable Trust, DC Thomson Charitable Trust and Tay Charitable Trust.

Appreciation is expressed also to Leisure and Culture Dundee, Dundee City Council, Susan Gillan, Halls & Music Development Manager, the Caird Hall staff and Stuart Muir, City Organist for their support of the organ and of the Friends.

Financial Review

During the period under review £2,077 was received in membership subscriptions and £7,929 in other unrestricted donations. Ninety eight members' subscriptions were paid by bank standing order. Grants totalling £9,200 were received from charitable bodies. A total of £22,568 was spent on charitable activities.

Reserves Policy

It is the Trustees' policy to hold reserves adequate to meet anticipated expenditure and to accumulate funds to support future developments for the organ. At the end of the accounting period the Charity held unrestricted cash funds of £27,639. The Trustees also held £3,504 in restricted funds which have been provided for the purposes specified in Note 2.

Statement of Trustees' Responsibilities

The Trustees must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Charity during the accounting period. The Trustees are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Charity at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. They are also responsible for safeguarding the assets of the Charity and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.



Notes to the accounts

1 Basis of preparation of accounts

The accounts have been prepared under the historical cost convention and are in accordance with applicable accounting standards, the Charities Accounts (Scotland) Regulations 2006 and Accounting and Reporting by Charities Statement of Recommended Practice (SORP) issued in 2005.

2 Funds

Unrestricted funds are those that may be used at the discretion of the trustees in furtherance of the objects of the charity.

Restricted funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes.

The charity has two Restricted Funds - Hollins Archive Event (created in 2014/15 and has a balance of £1,504) and Primary Schools Events (which has a balance of £2,000 from a Trust Donation made this year).

3 Trustee remuneration, benefits and expenses

No remuneration was paid to a charity trustee.

4 Membership

Membership subscriptions totalling £2,077 were received from 183 Ordinary members during this accounting period. Gift Aid has been recovered from membership fees and donations.

Independent Examiner's Report

I report on the accounts of the Charity for the year ended 31 March 2019 as set out above.
